

Terms and Conditions – Caribbean

Sizzlin' Summah Promotion

1. Promotion Description

Customers who send funds through JN Money Services Limited (JN Money) will automatically be entered to be a winner during the promotional period of July 7 to September 30, 2025, in the Sizzlin' Summah Promotion.

This promotion gives JN Money senders in the Caribbean, specifically Guyana, Turks & Caicos, and Antigua & Barbuda, the chance to win a weekend getaway for two. One (1) winner will be selected from a pool of agent locations from the Caribbean for a weekend getaway for two, in their country of entry, covering accommodation valued at USD \$1,500:

- **Guyana:** Marriott Hotel, Georgetown
- **Turks & Caicos:** Alexandra Resorts, Grace Bay
- **Antigua & Barbuda:** Hodges Bay Resort & Spa, St. John's

2. Eligibility for Entry

This promotion is open only to JN Money senders in the Caribbean (Guyana, Turks & Caicos and Antigua & Barbuda), who are 18 years of age or older at the time of entry. Employees and immediate family members of JN Money Services Limited, parent companies, affiliates, subsidiaries, agents, and their advertising and production agencies are not eligible to participate in this promotion.

3. Prizes

- Transactions not cancelled.
- Transactions disbursed.

Entrants who send money transfers during the promotional period will be randomly selected as per the schedule below:

One entrant (potential winner) will be randomly selected, via a draw, at the end of the promotional period for the grand prize from among all qualified entries for the promotion. Three additional entries (back-up potential winners) will also be selected from among all entries for the promotion in the event any of the potential winners do not qualify to be confirmed as a winner.

To be confirmed as a winner of the Sizzlin' Summah Promotion the following notification criteria must be satisfied:

- Telephone calls made in the order of which they appear on the potential winner list.
- On the day of the draw, three (3) consecutive telephone calls will be attempted to reach a potential winner in keeping with the order the names appear on the potential winner list.
- A failed attempt is when the phone rings without an answer, goes to voicemail, is busy or answered by someone other than the person JN Money is attempting to reach.
