# Terms and Conditions – UK Sizzlin' Summah Promotion

#### 1. Promotion Description

Residents who conduct transactions or Mail-In an Entry will be automatically entered to be a winner during the promotional period of July 7 to September 30, 2025, in the Sizzlin' Summah Promotion.

This promotion will give JN Money senders (Branches, Agents or Online) or mail-in entrants in the United Kingdom, the chance to win one of the following:

- **a.** Monthly Prize: One (1) winner will be selected from a pool of mail-in entries, branches, agent locations and JN Money Online each month for a total of three (3) winners. Each winner will receive free JN Money transaction fees for one year. Free fees are capped at a maximum transaction value of £500.
- **b.** Grand Prize: One (1) winner will be selected from a pool of mail-in entries, branches, agent locations and JN Money Online for a weekend getaway for two to Lisbon, Portugal including round-trip flights and accommodation valued at £1,500.

## 2. Mail-In Entries
