

Terms and Conditions – USA SE

Tech it to di Max Back to School Promotion

1. Promotion Description

JN Money transfer senders (Branches, Agents or Online) or mail-in entrants in Florida and Georgia have a chance to be a winner in Tech it to di Max Back to School Promotion from August 4 to September 30, 2025.

2. Mail-In Entries

To enter the promotion without conducting a Money Transfer transaction, participants may send a postcard or a letter with your contact information (full name, address, and phone number, etc.) with suitable postage to:

Mail-in entries are limited to one entry per mailing envelope. If received without all the requisite information will be deemed void. JN Money Services (USA), Inc. (JN Money) is not responsible for late, lost, incomplete, illegible, or misdirected mail. Mail-in entries must be postmarked no later than September 30, 2025.

The number of entries per person, during the promotional period, is not limited regardless of method of entry.

3. Eligibility for Entry

This promotion is open only to residents of Florida and Georgia, who are 18 years of age or older at the time of entry. Employees and immediate family members of JN Money Services (USA), Inc., parent companies, affiliates, subsidiaries, agents, and their advertising and production agencies are not eligible to participate in this promotion.

4. Prizes

This Promotion will give JN Money senders and mail-in entrants in Florida and Georgia the chance to be one of five winners of a 10-inch Tablet valued at USD \$300 at the end of the promotional period.

Prizes may not be transferred or assigned by the winner.

5. Eligibility for prize drawings will be determined by the following:

- Money transfer transactions conducted during the promotional period of August 4 to September 30, 2025.
- Transactions not cancelled.
- Mail-in entries post marked August 4 to September 30, 2025.

6. Method of Selection of Participants

Winners will be randomly selected from entrants that send money transfers during the promotional period or submit a mail-in entry, as per the schedule below:

Twenty (20) entrants (potential winner) will be randomly selected, via a draw, at the end of the promotional period. The first five (5) entrants drawn are considered the potential winners while the other entrants drawn are considered potential back-up winners ranked in the order they were drawn in the event the preceding potential winners do not qualify to be confirmed as a winner.

To be confirmed as a winner of the Tech it to di Max Back to School Promotion the following notification criteria must be satisfied:

- Telephone calls made in the order of which they appear on the potential winner list.
- On the day of the draw, three (3) consecutive telephone calls will be attempted to reach a potential winner in keeping with the order the names appear on the potential winner list. A failed attempt is when the phone rings without an answer, goes to voicemail, is busy or answered by someone other than the person JN Money is attempting to reach.
- The entrant answers and identify themselves as the person JN Money intended to reach.
