

## **Terms and Conditions – Canada**

### **Sizzlin’ Summah Promotion**

#### **1. Promotion Description**

JN Money transfer senders (Branches, Agents or Online) or mail-in entrants in Canada except Quebec have a chance to be a winner in our Sizzlin’ Summah Promotion from July 7, 2025, to September 30, 2025.

#### **2. Mail-In Entries**

To enter the promotion without conducting a Money Transfer transaction, participants may send a postcard or a letter with your contact information (full name, address, and phone number, etc.) with suitable postage to:

Mail-in entries are limited to one entry per mailing envelope and if received without all the requisite information will be deemed void. JN Money Services (Canada), Ltd. (JN Money) is not responsible for late, lost, incomplete, illegible, or misdirected mail. Mail-in entries must be postmarked no later than September 30, 2025.

The number of entries per person, during the promotional period, is not limited regardless of method of entry.

#### **3. Eligibility for Entry**

This promotion is open only to residents of Canada (with the exemption of residents of Quebec) who are 18 years of age or older at the time of entry. Employees and immediate family members of JN Money Services (Canada), Ltd., parent companies, subsidiaries, agents, and their advertising and production agencies are not eligible to participate in this promotion.

#### **4. Prizes**

This Promotion will give JN Money senders and mail-in entrants in Canada, except Quebec, the chance to win one of the following prizes during the promotional period:

- a. **Monthly Prizes:** One (1) winner each of the three (3) months (July, August & September) will receive free JN Money transaction fees for one (1) year. Limited to a maximum of one transaction per month not valued in excess of CAD \$500.
- b. **Grand Prize:** One (1) winner will be selected for a weekend for two getaway to Oak City, British Columbia including round-trip flights and hotel accommodation valued at up to CAD \$1,500.00.

Prizes may not be transferred or assigned by the winner.

#### **5. Eligibility for prize drawings will be determined by the following:**

- Money transfer transactions conducted during the promotional period of July 7 to September 30, 2025.

- Transactions not cancelled.
- Mail-in entries post marked July 7 to September 30, 2025.

## 6. Method of Selection of Participants

Winers will be randomly selected from entrants that send money transfers during the promotional period or submit a mail-in entry, as per the schedule below:

Four (4) entrants (potential winner) will be randomly selected, via a draw, at the end of each month for the monthly prize. Similarly, four (4) entrants (potential winner) will be drawn at the end of the promotional period for the grand prize. The first entrant drawn is considered the potential winner for each draw while the other entrants drawn are considered potential back-up winners ranked in the order they were drawn in the event the preceding potential winners do not qualify to be confirmed as a winner.

To be confirmed as a winner of the Sizzlin' Summah Promotion the following notification criteria must be satisfied:

- Telephone calls made in the order of which they appear on the potential winner list.
- On the day of the draw, three (3) consecutive telephone calls will be attempted to reach a potential winner in keeping with the order the names appear on the potential winner list. A failed attempt is when the phone rings without an answer, goes to voicemail, is busy or answered by someone other than the person JN Money is attempting to reach.
- The entrant answers and identify themselves as the person JN Money intended to reach.
- Upon successful validation entrant will be selected as the respective winner.

The successful winners will be advised of the date and time to retrieve their prize. A replacement winner may be chosen if the previously chosen winner is unable to claim their prize within the time specified by JN Money.

## 7. Odds of Winning

The odds of winning depend on the number of entries received.

## 8. Test of skill

Selected entrants will only be considered a winner if they satisfy the test of skill. Selectants will be required to complete the following: "What is  $(2 \times 3) + (10 \times 3)$ ". Upon successful completion of the test, the selectant will be considered a winner.

## **9. Conditions of Acceptance of Prize**

Winners will be required to produce a valid Government Issued photo Identification document to claim their prize. Within one (1) day of prize notification, the winners will be required to send a written agreement (via email) to confirm that they will accept the prize, or the prize will be forfeited. If the winners fail to meet the conditions of claiming and accepting the prize, an alternative winner may be selected.
