Terms and Conditions - Caribbean

Tech it to di Max Back to School Promotion

1. Promotion Description

Customers who send funds through JN Money Services Limited (JN Money) will automatically be entered to be a winner in our Tech it to di Max Back to School Promotion from August 4 to September 30, 2025.

This promotion gives JN Money senders or receivers in the Caribbean, specifically Guyana, Turks & Caicos, and Antigua & Barbuda, the chance to win a 10-inch tablet as part of our Tech It to di Max Back-to-School promotion.

2. Eligibility for Entry

This promotion is open only to JN Money senders in the Caribbean (Guyana, Turks & Caicos and Antigua & Barbuda), who are 18 years of age or older at the time of entry. - Transactions not cancelled.
- Transactions disbursed.

5. Method of Selection of Participants

Twenty (20) entrants (potential winner) will be randomly selected, via a draw, at the end of the promotional period. The first five (5) entrants drawn are considered the potential winners while the other entrants drawn are

considered potential back-up winners ranked in the order they were drawn in the event the preceding potential winners do not qualify to be confirmed as a winner.
