

Terms and Conditions – Jamaica

Tech it to di Max Back to School Promotion

1. Promotion Description

Customers who send or receive funds through JN Money are automatically entered to be a winner in our Tech it to di Max Back to School Promotion from August 4 to September 30, 2025.

This promotion will give JN Money senders and recipients in Jamaica the chance to win a 10-inch tablet as part of our Tech It to di Max Back-to-School promotion.

2. Eligibility for Entry

This promotion is open only to JN Money senders and recipients in Jamaica, who are 18 years of age or older at the time of entry. Employees and immediate family members of JN Money Services Limited, parent companies, affiliates, subsidiaries, agents, and their advertising and production agencies are not eligible to participate in this promotion.

3. Prizes

This promotion will give JN Money senders and recipients in Jamaica the chance to win a tablet. Five (5) winners will be selected from a pool of entrants from Agent Locations to win one (1) tablet valued at JMD40,000.

Prizes may not be transferred or assigned by the winner.

4. Eligibility for prize drawings will be determined by the following:

- Money transfer transactions conducted during the promotional period of August 4 to September 30, 2025.
- Transactions not cancelled.
- Transactions disbursed.

5. Method of Selection of Participants

Entrants who send or receive money transfers during the promotional period will be randomly selected as per the schedule below:

Twenty (20) entrants (potential winner) will be randomly selected, via a draw, at the end of the promotional period. The first five (5) entrants drawn are considered the potential winners while the other entrants drawn are considered potential back-up winners ranked in the order they were drawn in the event the preceding potential winners do not qualify to be confirmed as a winner.

To be confirmed as a winner of the Tech it to di Max Back to School Promotion the following notification criteria must be satisfied:

- Telephone calls made in the order of which they appear on the potential winner list.
- On the day of the draw, three (3) consecutive telephone calls will be attempted to reach a potential winner in keeping with the order the names appear on the potential winner list. A failed attempt is when the phone rings without an answer, goes to voicemail, is busy or answered by someone other than the person JN Money is attempting to reach.
- The entrant answers and identify themselves as the person JN Money intended to reach.
- Upon successful validation the entrant will be selected as the respective winner.

The successful winners will be advised of the date and time to retrieve their prize. A replacement winner may be chosen if the previous chosen winner is unable to claim their prize within the time specified by JN Money.

6. Odds of Winning

The odds of winning depend on the number of entries received.

7. Conditions of Acceptance of Prize

The winner will be required to produce a valid Government Issued photo Identification (Passport, National ID or Driver's Licence) document to claim their prize. Within one (1) day of prize notification, the winner will be required to send a written agreement (via email) to confirm that they will accept the prize, or the prize will be forfeited. The winner must visit the selected JN Money location within five (5) days of notification (excluding weekends) for the prize handover. Failure to claim the prize within five (5) days, will result in its forfeiture. In such an event, a back-up winner will be contacted in the order in which they were drawn.
