Terms and Conditions - Cayman

Tech it to di Max Back to School Promotion

1. Promotion Description

Customers who send funds through JN Money Services (Cayman) Limited (JN Money) will automatically be entered to be a winner our Tech it to di Max Back to School Promotion from August 4 to September 30, 2025.

This promotion will give JN Money senders and recipients in the Cayman Islands the chance to win a 10-inch tablet as part of our Tech It to di Max Back-to-School promotion.

2. Eligibility for Entry

This promotion is open only to JN Money senders in the Cayman Islands, who are 18 years of age or older at the time of entry. Twenty (20) entrants (potential winner) will be randomly selected, via a draw, at the end of the promotional period. The first five (5) entrants drawn are considered the potential winners while the other entrants drawn are considered potential back-up winners ranked in the order they were drawn in the event the preceding potential winners do not qualify to be confirmed as a winner.
