

Terms and Conditions – UK

Summer Kickout Promotion

1. Promotion Description

JN Money transfer senders (Branches, Agents or Online) or mail-in will be automatically entered in our Summer Kickout Promotion from May 22 to July 31, 2026.

This promotion will give JN Money senders (Branches, Agents or Online) or mail-in entrants in the UK, the chance to win one of the following:

- a. **FREE Transfer Monthly Prize:** Two (2) winners will be selected each month, one from a Branch and one from an Agent location, during the promotion period (June and July). Each winner will receive free JN Money transaction fees for one (1) year. Limited to a maximum of one transaction per month, not valued in excess of GBP £500
- b. **Rep Yuh Team Prize:** Two (2) winners will be selected to win an Official FIFA World Cup Jersey. Customers will have the opportunity to complete an entry form for a chance to win.

2. Mail-In Entries

To enter the promotion without conducting a Money Transfer transaction, participants may send a postcard or a letter with your contact information (full name, address, and phone number, etc.) with suitable postage to:

Six (6) entrants (potential winners) will be randomly selected via a draw at the end of each month for the monthly prize of a FREE Transfer.
